#### 1. What are Cookies

Cookies are small text files that are placed on your device when you access our platform. ### 2. Types of Cookies We Use

- b. Analytical and performance Cookies: we use these cookies to collect information about how users interact with our platform, including pages visited, time spent on each page and error messages. This data helps us analyze and improve the performance and usability of our platform
- c. Advertising and Marketing Cookies: these cookies are used to deliver relevant advertising to users and track the effectiveness of marketing campaigns. They may collect information about your browsing activities across different websites and apps to provide personalized adds.
- d. Third Party Cookies: We may allow third-party service providers, such as analytics providers and advertising networks to place cookies on your device. These cookies are subject to the privacy policies of the respective providers

### 3. Managing Cookie Preference

- **a.** Consent: by using our platform, you consent to the placement of cookies on your device as described in this Cookie Policy. You can withdraw your consent at any time by adjusting your cookie settings in your device or browser
